### **iLOOKABOUT Announces Series E Warrant Term Extension**

**LONDON, Ontario, Canada** – March 3, 2011. iLOOKABOUT Corp. (TSXV: ILA) (“iLOOKABOUT” or the “Company”) announced today that, subject to the approval of the TSX Venture Exchange (“TSXV”), it will extend the term of its Series E common share purchase warrants (the “Class E Warrants” or the “Warrants”) issued in conjunction with the February 22, 2008 private placement.

Each full Class E Warrant entitles its holder to purchase one common share of the Company at an exercise price of \$1.00 per share. While these Warrants were originally scheduled to expire on April 1, 2010, the Company, in March 2010, extended the term of the Warrants to the earlier of (i) 5:00 p.m. (EST) on April 1, 2011, or (ii) 5:00 p.m. (EST) on the 30th calendar day following the Company’s common shares attaining a closing price of \$1.20 or greater for ten consecutive trading days on the TSXV. Subject to the approval of the TSXV, the term of the Class E Warrants will be further extended to the earlier of (i) 5:00 p.m. (EST) on April 1, 2012, or (ii) 5:00 p.m. (EST) on the 30th calendar day following the Company’s common shares attaining a closing price of \$1.20 or greater for ten consecutive trading days on the TSXV. To date, none of the Class E Warrants have been exercised.

Subject to TSXV approval of the foregoing, the Company will be delivering replacement warrant certificates that reflect the amended expiry date to holders of the Class E Warrants in due course.
