iLOOKABOUT Announces Results of the Annual & Special Meeting of Shareholders and the Grant of Deferred Share Units

LONDON, Ontario, Canada – May 30, 2016 - iLOOKABOUT Corp. (TSXV: ILA) (the "Company") is pleased to announce the results of the Annual & Special Meeting of Shareholders (the "Meeting") held in London, Ontario on May 30, 2016. The shareholders approved the following motions put forth at the Meeting:

- Election of Allan Bezanson, John C. Drake, Jeff Hack, Peter Hyde, Gerald C. Quinn, Gary Yeoman, and Jeff Young as Directors, each for a term of one year;
- Re-appointment of KPMG LLP as the Company's auditor and authorization for the directors to fix the auditors' remuneration; and
- Re-approval of the Company's Stock Option Plan set out in Exhibit A of the Management Information Circular dated April 25, 2016.

The Company also confirmed that, in accordance with the Directors Deferred Share Unit Plan that was approved by the shareholders of iLOOKABOUT at its 2014 Annual and Special Meeting of Shareholders, the Company has credited Directors' Deferred Share Unit Accounts with an aggregate of 299,998 Deferred Share Units in respect of their services to the Company from January 1, 2016 up to the Annual and Special Meeting of Shareholders.
