



## **Results of the Annual and Special Meeting of Shareholders**

**LONDON, Ontario, Canada** – May 26, 2011. iLOOKABOUT Corp. (TSXV: ILA) (the “Company”) is pleased to announce the results of the Annual and Special Meeting (the “Meeting”) of shareholders held in London, Ontario on May 25, 2011. The shareholders approved all motions put forth at the meeting, including the re-appointment of KPMG LLP as the Company’s auditor and the approval of the Company’s amended Stock Option Plan in accordance with TSX Venture Exchange requirements. The proposed slate of nominee directors was comprised of Mr. Jeff Hack, Mr. John Kennedy and Mr. Jeff Young, each for a period of approximately three years, and was also approved.

At their meeting held following the Annual and Special Meeting, the newly constituted Board appointed Mr. Geoff Davies as Chairman of the Board. Mr. John C. Drake, previous Chairman, welcomed Mr. Davies to his new position, and went on to confirm his previously expressed sentiments that the Company is at a stage that will benefit from the extensive experience of Mr. Davies, as a previous Chief Executive Officer of a publicly listed company. The appointment of an independent director to this position is also consistent with the Company’s objectives to improve its structure with respect to Corporate best practices related to Governance. Mr. Drake noted that he looks forward to continuing to serve actively on the Board of iLOOKABOUT.

As previously announced, effective at the close of the Meeting, Mr. Alfred A. Jay resigned as a Director of the Company. Mr. Jay decided not to seek re-election due to other commitments. Members of Management and the Board expressed a sincere appreciation to Mr. Jay for his extensive commitment and contributions to iLOOKABOUT over the past ten years.
